Dear Jet Time passenger,

We apologize for the flight delay and for the possible inconveniences the delay might have caused.

According to the EG261/2006 Regulation, passengers might be eligible for compensations if their flight is delayed as follows:

1. EUR 250,- on flights of 1,500 kilometers or less.
2. EUR 400,- on intra-EU*) flights of more than 1,500 kilometers.
3. EUR 400,- on other flights between 1,500 and 3,500 kilometers.
4. EUR 600,- on all flights not falling under 1), 2) and 3)

*) intra-EU: EU countries and Norway, Switzerland and Lichtenstein. Please note that Canary Islands are part of EU.

Please note that Jet Time is not obligated to compensate for any extra costs acquired due to delay (e.g. extra parking fees, missing salaries, extra connection travel etc.). We recommend you contact your Travel Insurance.

How to fill in the Delay Compensation Form

If you are seeking delay compensation only for yourself, please fill out only page 1. Otherwise, please also fill out the Power of Attorney (PoA) on pages 2 – 3. Please fill out the form on the computer screen (except signatures) or write in block letters.

Flight delay compensation is always personal compensation paid to individual passenger, regardless of who paid for the ticket. Therefore, if you are seeking compensation on behalf of others, you will have to submit a PoA from that person (pp. 2 – 3).

Please note that the form has to be signed by hand, therefore it is necessary to print the form before signing. After signing, you can take a photo or scan the document and email it to Jet Time. (eu261@jet-time.dk).

If a passenger claiming compensations is under 18 years old, the PoA have to be signed by the child's legal guardian.

Instructions for page 1:

- Booking number = Tour Operator's ticket number. If you are seeking compensation on behalf of several passengers, please write all booking numbers here.
- Date of departure = Scheduled date for the delayed flight.
- Flight number = The number for delayed flight. Please note that the outbound and homebound flights have different numbers.
- Airport of departure, Airport of arrival = Scheduled departure and destination airports for the delayed flight.
- Persons over and under 18 year = Total number of travelers included in the claim.
- Signature: Claimer's signature by hand. Please note that due to Danish laws, computer generated signatures are not accepted.
- Account details: if you have a Danish bank account, please fill in your account number in domestic format. In all other cases (as Jet Time will transfer funds from Denmark), the bank account has to be in international format (IBAN account number and bank's BIC/SWIFT code). Please consult your bank statement, online bank or contact your bank's Customer Service.

Instructions for pages 2 - 3:

- Recipient of the compensation = Same as claimer on page 1.
- Information of fellow travelers. Please fill in the names and street addresses of all travelers seeking compensation (including those who are under 18). Do not forget booking number, esp. if you are seeking compensations on behalf of several persons.
- Details of the delayed flight: please use the scheduled dates, even if the flight was significantly delayed.
- Date, place and signatures: please note that due to Danish laws, computer generated signatures are not accepted.

Please email the filled form and possible attachments to 261@jet-time.dk. Note that there is a significant delay on handling time if you choose to send the compensation form via postal service.
